Nottawaseppi Huron Band of the Potawatomi Tribal Council Members Take Oath of Office

FULTON -- On May 19, 2016, the Nottawaseppi Huron Band of the Potawatomi issued the oath of office to newly-re-elected Tribal Council Members Homer A. Mandoka and Jamie Stuck.

Upon completion of the oath of office, NHBP Tribal Council conducted its officers' appointments. Jamie Stuck was appointed Chairperson and Dorie Rios was appointed Vice-Chairperson. Christine Lanning was appointed as Secretary; Tony Day was appointed as Treasurer, and Homer A. Mandoka was appointed Sergeant-at-Arms.

"The combined wealth of experience and dedication of our Tribal Council will allow us to continue to provide a strong and stable government for our Tribal Members and to ensure that our actions prepare our Tribe to meet the needs of the next seven generations," Stuck said.

Stuck, of Scotts, has served on Tribal Council since 2006; Rios, of Battle Creek, has served on Tribal Council since 2010; Lanning, of Newaygo, has served on Tribal Council since 2013; Day, of Union City, has served on Tribal Council since 2012; and Mandoka, of Bronson, has served on Tribal Council since 2002.

NHBP Tribal Council Adopts New Flag

At the May 19 Tribal Council meeting the Nottawaseppi Huron Band of the Potawatomi adopted a revision of the official NHBP Flag.

The revision process began during spring of 2014, when Tribal Council began a process to evaluate the use of NHBP's logo and branding. As a part of that process, it was discovered that the turtle logo had changed from the original version as it had been originally presented to the Tribe by Native artist Candi Wesaw and Tribal Member Gary Mandoka.

Since that time, Tribal Members have had several opportunities to view the proposed revisions to the Tribal Flag and share their comments with Tribal Council regarding those options.

The proposed flag returns the turtle artwork to the original artists' version, incorporates the complete Tribal name as it appears in NHBP's Constitution and affords the flag all of the protections provided for the Tribal Seal through the Tribal Seal Use Code.

The following is the Education Requirement from the NHBP Revenue Allocation Plan:

In order for an eligible Member between the ages of eighteen (18) and twenty-one (21) years of age to receive a per capita payment directly, such Member must submit to the Enrollment Office or Tribal Council, one of the following:

- ① a copy of his/her high school diploma,
- ② a copy of his/her degree or certificate equivalent to a high school diploma,
- ③ documentary proof of satisfactory completion of high school degree-equivalent home schooling requirements for the member's state of residence, or
- ④ a certification from an accredited school or schools that the member has learning or other disabilities and has attended a full twelve years of school.

NHBP Youth: Austin Chivis' Wrestling Skills Shine on Mat

Austin Chivis recently won the 2016 Michigan Youth Wrestling Association State championship held at the Battle Creek Kellogg Arena, but this isn't his first time – and it likely won't be his final time if he continues his champion-style wrestling.

He turned 11 in May, but already Austin has won several major awards: a Future Stars State championship in 2013, which was his first major award as a second-grader; two MYWA State championships – in 2014 and 2016; and earlier this year, Austin took fifth place in the Nation at the NUWAY Wrestling Nationals for Youth.

Still, his career began just a few short years ago. His career began to blossom when Austin's father, Jason Chivis, had an idea for Austin to join the Thornapple Middleville Wrestling Club. After joining, things quickly escalated for Austin, including him winning local and regional tournaments throughout Michigan, Jason Chivis said.

Austin's success has come from a mixed bag of great coaching from his former wrestling champion father, talent and his drive to perfect the sport.

"I'm really, really happy for Austin," Chivis said. "He has been very committed, he's worked exceptionally hard and he's done things that a lot of kids just don't do – he puts in the extra time to be the best he can be."

Jason Chivis has been around the sport for more than 30 years as a wrestler in high school and college, then as a middle school and high school wrestling coach for numerous years.

"The strategy of the game is what I enjoy teaching," Jason Chivis said. "I know a lot of things about the sport of wrestling others don't, ultimately this helps my son Austin excel."

One of Austin's most recent major wrestling successes was in April at Battle Creek Kellogg Arena during the MYWA State championships. Austin wrestled in the 85-pound weight class consisting of the 32 best wrestlers in the State of Michigan, and wrestled his way to first-place winning five straight matches to claim the State title.

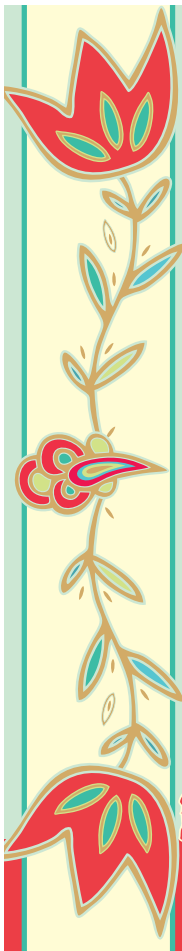

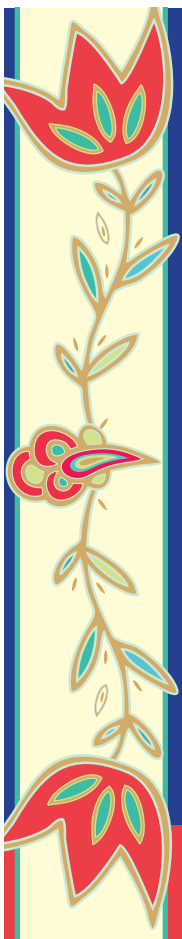

NHBP Staffer Recalls Hunting “Massive” Tom

NHBP Administrative Assistant and NHBP Tribal Member Angela Allen spent a weekend in May hunting on T Drive South near the Central Sanitary Plant, and she came away with quite a prize – and a story to share. She is donating her prize to the NHBP Environmental Department for an upcoming Elder-related event. Read Angela’s story below.

It was early morning, sitting on the side of the field in the brush, as I called to see if there were any turkeys in the area. Around 6:45 a.m., there was a loud gobble back. I knew it had to be a big tom because the turkey was all by itself.

I called him in by using a box call and a mouth piece. I could hear him getting closer and closer, so I remained still, so he could not see me. I had a big tom decoy and two hen decoys to lure him in. The tom came in cautiously from the woods to the edge of the field and stood tall. He stuck his head way up in the air and moved it from side-to-side to take a look at the decoys and his surroundings.

The bird was massive and was 25 yards from where I was seated. It was a very windy morning, so the feathers on the back of my tom decoy were partially blown down on the back of it. He knew something wasn’t right. He then looked directly at me. He knew I was there. He spotted me. He started to walk away, then turned around one last time.

That’s when I shot him with my 20 gauge shotgun. Bird down! The bird weighed 26.5 pounds, had a 10 inch beard, and 1 ¼ inch spurs. This was the best turkey hunt I have ever had with the biggest turkey I have ever harvested. I am so thankful for our native lands and for this beautiful bird.

NHBP, Other Michigan Tribes Receive Award from Michigan Historic Preservation Network

For a second year in a row, NHBP is one of several Tribes in Michigan who won a state award for cooperative efforts in consulting with archaeologists on the planning and building of the new M-231 bypass that crosses the Grand River – and former Tribal territory. The site is located east of Grand Haven in Ottawa County, which is within the Tribe's seven-county service area.

The Tribe's critical consulting role came early on in the planning stages of the bypass project, when state of Michigan officials worked with NHBP to determine whether the bypass project would cross anything with cultural or religious significance.

"We worked in cooperation to investigate the site, and we learned, too, from the findings," said NHBP Environmental Director John Rodwan.

Archaeologists did, in fact, find evidence of seasonal encampments and food caches that Native Americans built thousands of years ago. Rodwan said that is evidence of cultural history that NHBP Members can record. Because of this project, Tribes in Michigan and Michigan state departments have been rewarded for their work.

"This is the second agency that has awarded the Tribe for its cooperative efforts in working with a state agency on this project," said Rodwan, who added that the cooperative work sets precedence for other agencies to approach Tribes early in the project stages.

The Tribe received the Michigan Historic Preservation Network's 2016 Government Institution Award during a reception on May 13, held at the Garden Theater in Detroit, for their part in the Archaeological Data Recoveries.

This award is given to organizations or agencies who have accomplished significant positive changes in the historic preservation climate and has made a significant contribution to the preservation of Michigan's heritage. The Tribes won the State of Michigan Governor's Award in 2015 for the same project.

Among the recipients who traveled to receive this Government Institution Award was NHBP Cultural Historic

Preservation Office Manager Beth Moody, who worked in collaboration with Rodwan in consultation with the state of Michigan.

The Tribal co-awardees include the Grand Traverse Band of Ottawa & Chippewa Indians, Little River Band of Ottawa Indians, Little Traverse Bay Bands of Odawa Indians, Match-e-be-nash-she-wish Band of Pottawatomi Indians, and the Saginaw Chippewa Indian Tribe. The same Archaeological Data Recoveries award also included the Michigan Department of Transportation, Environmental Section, Michigan State Historic Preservation Office and the Commonwealth Heritage Group for their work on the project.

The award is one of several Government Institution Awards given during the ceremony. Other awards went to the City of Monroe for its River Raisin Heritage Corridor project and to the St. Clair County Regional Educational Service Agency.

Several Lifetime Achievement Awards also were given to distinguished Michigan historic preservationists.

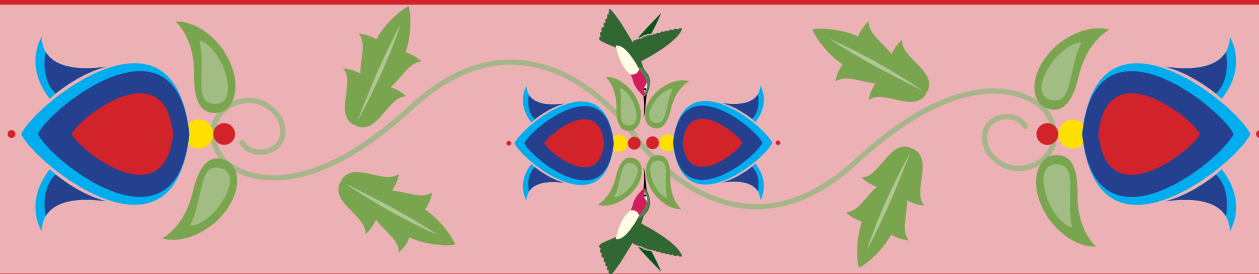

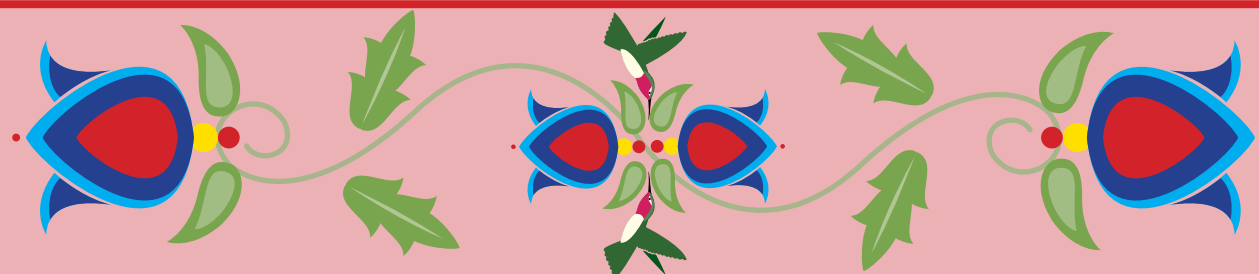

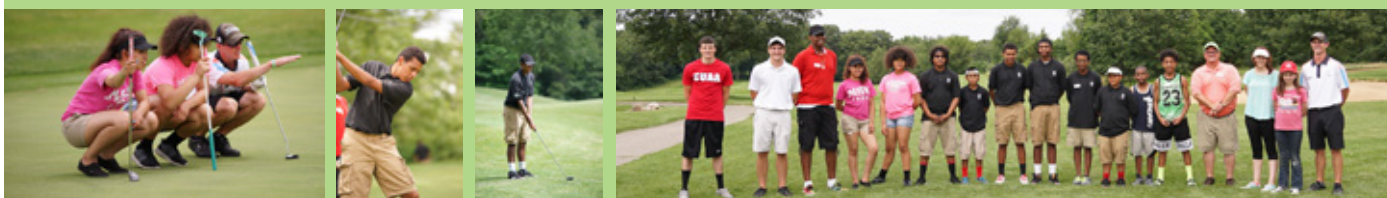

Domestic Violence Code – Questions and Answers

Questions from the Community Meetings held on March 7 & 9, 2016

Question 1:

How do I prove that I need time off work because I'm helping a family member with a domestic violence incident and my family member doesn't want to press charges or doesn't feel safe sharing publicly what is going on?

Answer: The Domestic Violence Leave Act is found at Section 7.4-62 in the Code. This section provides that employees may not be terminated for missing work if they can document within 14 days that they have missed work because of an incidence of domestic violence. It is understandable that an employee may not want to speak to anyone, especially at work about domestic violence. There will be other ways that the employee can document why they missed work, for example, the DV Victim's Advocate may be able to assist or a person or professional that is familiar with victims. These persons can assist the employee with getting supporting documentation. Also, there are various options of what would be acceptable as documentation. The policies for the DV Leave Act are currently being drafted and will be forthcoming next month and will include examples of the required documentation.

Question 2:

How long can a prison sentence be?

Answer: Currently, the Court may sentence an individual to jail for up to one year and a fine of up to \$5,000, or both. That is the maximum amount of time the Judge can sentence persons to jail. But, if a person has multiple charges the Court could sentence them to serve out each jail term one after the other. So for example, if they had two separate charges for one year each the Judge could sentence them to serve the two one year sentences for each crime one after the other.

Question 3:

What other conditions or probation terms can the court use?

Answer: The DV Code allows different options for

the Judge to determine the appropriate conditions and terms of probation for crimes of domestic violence. Upon conviction of a crime of domestic violence, the perpetrator will be required to complete a domestic violence perpetrator treatment program. Restitution may also be ordered by the Court which will help restore the victim; for example, to pay for lost or destroyed property of the victim, and fines, fees, and costs. The Court may, at the request of the Prosecutor, issue an order of exclusion, which excludes the perpetrator from all or a portion of the NHBP Indian Reservation and territory consistent and subject to the scope and conditions of the Exclusion Code.

Question 4:

What about termination of parental rights?

Answer: Termination of parental rights is not included in the Domestic Violence code, but will be covered in the upcoming Children's Protection Code, which will address ways parental rights are terminated.

Question 5:

Can you tell me about how juveniles are treated differently?

Answer: Juveniles that commit violations of the DV Code are defined as individuals under the age of 18. Juveniles who commit acts of domestic or family violence will be prosecuted under the DV Code and are within the jurisdiction of the Tribal Court rather than the Juvenile Court. But an arrest and prosecution of a juvenile under the DV Code does not bar proceedings in the Juvenile Court.

Question 6:

If someone commits domestic violence but the prosecutor fails to prove the intimate relationship needed, can someone then get a protection order?

Answer: Yes, they would be able to get a protection order. If the prosecutor fails to prove an intimate relationship, a non-Indian person does not fall under the jurisdiction of the tribe's authority to prosecute for domestic violence. However, if there is still an immediate threat of harassment, threats, or contact

with the victim, the victim may petition the court to obtain a protection order. If the perpetrator sexually assaulted the victim, the victim may petition the court for a sexual assault protection order as well.

Question 7:

Can the tribe prosecute and the federal government prosecute someone at the same time?

Answer: Yes, the Tribe and the Federal Government can prosecute a perpetrator for the same crime. This is not considered double jeopardy because the Tribe and the Federal government are two separate governments. Double jeopardy means a second prosecution for the same offense. Double jeopardy only applies when the same government tries to prosecute someone more than once for the same crime.

Question 8:

What happens when someone commits domestic violence more than three times?

Answer: If the person has two or more convictions for domestic violence, they could be charged as a habitual domestic violence or family violence offender, which is a felony.

Question 9:

Is a civil protection order good enough to get the benefit of the Domestic Violence Leave Act?

Answer: Yes, the DV Code requires that documentation be made within 14 days and receiving a civil protection order would be considered documentation of domestic violence. The person requesting the protection order must be a victim of domestic violence, family violence, dating violence, or stalking. Section 7.4-63 of the DV Code provides examples of documentation for the DV Leave Act; for example, a document from a civil or criminal proceedings in a court of law, a protection order, or another type of document that is satisfactory to the Tribe.

Question 10:

Who will be paying for the non-Indian perpetrators lawyer?

Answer: Rights provided to the defendant or perpetrator, incorporates all of the rights of the Indian

Civil Rights Act (ICRA); for example, the right to remain silent, the right to a speedy trial, etc. Another right is to provide a defense attorney if they cannot afford one. The Tribal Court has a process to provide attorneys to persons if they cannot afford one. All criminal defendants in Tribal Court are entitled to court appointed assistance of counsel during a criminal proceeding if they are not able to pay for an attorney themselves.

Question 11:

Why do we need this if the federal government can prosecute the crime?

Answer: The federal government can prosecute the perpetrator but it is to the benefit of the community, the victim, and the Tribe, to prosecute crimes that occur on the reservation and within the Tribe's jurisdiction, not only to protect the community but to ensure justice. Historically, Tribal governments did not have authority to prosecute non-Indians that commit acts of domestic violence on the reservation. This has resulted in almost all cases involving non-Indians to go unprosecuted. The Federal government does not take the cases because they have limited resources to prosecute these cases, especially misdemeanor domestic violence cases. By enacting the DV Code and asserting special domestic violence criminal jurisdiction, the Tribe is asserting its inherent authority to prosecute crimes that occur on the reservation including non-Indians for crimes of domestic violence. The Tribe is better able to protect and serve its members and the community, and to prosecute crimes that occur on the reservation.

Question 12:

If I have a Michigan protection order for a past boyfriend, and I am at FireKeepers and I see him, what can Tribal Police do?

Answer: Tribal Police will be able to remove the individual based on the State of Michigan protection order and the full faith and credit provision that is found in the federal law. VAWA 2013 requires that Tribes and States recognize each other's protection orders. Therefore, Tribal Police will have authority to enforce the state protection order based on the authority in VAWA. The Tribal Court will be able to enforce any violations of state protection orders as if it were the order of the Tribal Court. The Tribal Court can

decide how the order is enforced, the detention and notification procedures, and the penalties and sanctions.

Question 13:

Will there be any educational programs for tribal youth to learn about domestic violence and help create a safer community for the future?

Answer: Yes, the NHBP Membership Department is already working on implementing educational components for tribal youth.

Question 14:

Why does the Domestic Violence Leave Act allow for unpaid leave?

Answer: The DV Leave Act allows for unpaid leave for employees because there may be times when the employee does not have any time remaining in their PTO bank to use for time off from work. The DV Leave Act allows for the employee to use paid or unpaid time away from work because of domestic violence or to assist a family member because of domestic violence. The DV Leave Act allows for substantial time away from work and NHBP is aware that there may be circumstances that require the employee to be away from work on unpaid status until they can return.

Question 15:

Can the language of the DV Code include a guarantee by Tribal Council today and in the future to have money set aside for tribal specific domestic violence programs here at Pine Creek, to create a program that will always be here on the reservation?

Answer: The Code does not provide for a specific amount of money to be used to pay for a domestic violence program. NHBP and Tribal Council understand how important the Code is for the Tribe and the rights that it gives to victims of domestic violence. While the services in place for domestic violence victims is certain to be continuing well into the future for the next seven generations, future earnings are unpredictable and therefore it is not certain how much can be allocated for these services. Tribal members who are interested in guaranteeing that the domestic violence program continue could create a grassroots campaign that can address domestic violence and bring it to the attention

of Tribal Council and also help find grant funding to support the domestic violence program.

Question 16:

How does the special domestic violence criminal jurisdiction in the Domestic Violence Code relate to the Dollar General Case, will the DV Code be overruled?

Answer: The Violence Against Women Reauthorization Act of 2013 (VAWA) was written and passed by the Congress of the United States. While the VAWA has limited jurisdiction over certain crimes of domestic violence committed by non-Indians, which is the special domestic violence criminal jurisdiction, it is a victory for Tribal governments to again be able to assert criminal jurisdiction over non-Indians. The Dollar General case is regarding a commercial business contract and civil jurisdiction over nonmember business activities on the reservation. The question in that case is whether the Tribal Court has jurisdiction over nonmember defendants in general, and more specifically, whether Tribal Courts have the independence required for fair treatment of nonmembers. VAWA could be struck down as unconstitutional and while that is certainly a possibility, we hope that is not the case. We also hope that the Supreme Court ruling in the Dollar General case will be in favor of Tribes and will not impact the rights of Tribes.

Question 17:

What is the extent of the changes made to the Fair Employment Practices Code?

Answer: The Fair Employment Practices Code (FEPC) provides at Section 801, Employment Leave for Victims of Violence. It was amended to include a reference to the Domestic Violence Code because it also has a Leave Act for victims of domestic violence. The FEPC and DV Code will be combined to provide one domestic violence leave policy for NHBP government employees. The policy is currently being drafted and will be forthcoming next month.

Attention: New Health and Human Services Policy Update

New Late/Missed Appointment Policy

Due to the high number of late arrivals and missed appointments, and the impact that it has on other patients waiting to see a service provider, the Health and Human Services Department has developed a late/missed appointment policy.

Late Arrivals:

If a patient arrives more than 15 minutes late for their scheduled appointment time, they may be rescheduled for a later date and time. If the patient is rescheduled for arriving more than 15 minutes late to their appointment it will be considered a "No Show" appointment.

Missed Appointments:

If a patient does not notify the Health and Human Services Department within 8 hours of their scheduled appointment time that they need to cancel, it will be considered a "No Show" appointment.

No Show:

After obtaining three "No Show" appointments for the same service, a patient will not be able to schedule an appointment with that service for three months. The patient will only be seen as a same day/walk-in patient if time permits.

Contract Health Services

Contract Health Services is funded through a grant from Indian Health Services. It is to help pay for medical services **not** offered through the NHBP Health Clinics.

What I should know:

- ◆ Contract Health is **not** a health insurance, it is a grant. Funds are limited and based on medical priorities.
- ◆ Contract Health **does not** guarantee payment.

Who is eligible for Contract Health Services?

- ◆ NHBP Tribal members living in the 7 county CHSDA; Allegan, Barry, Branch, Calhoun, Kalamazoo, Kent and Ottawa counties of Michigan.
- ◆ NHBP descendants under the age of 19.
- ◆ A non-Indian woman pregnant with an eligible Indian's child for the duration of her pregnancy through postpartum (6 weeks).

What will CHS pay for?

- ◆ CHS may help pay for medical/dental services outside of the NHBP Health Clinics **if** referred by one of NHBP's providers.
- ◆ CHS may help pay for vision services.
- ◆ CHS may help pay for prescriptions.

How do I get CHS to pay for these services?

- ◆ Provide notification through Contract Health prior to any service outside the NHBP Health Clinics.
- ◆ Notify contract health within 72 hours of an emergency room visit.
- ◆ Complete your CHS registration paperwork information yearly. A letter will be mailed to you when you need to update your information. If your yearly

registration requirements are not met, you will **not** be approved for funding.

- ◆ Apply for Medicaid or alternate resources if you do not have health insurance when applying for Contract Health. If you need help applying for Medicaid, please call Chris Woodring at 616.514.3638.

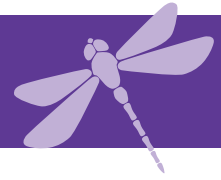
