The Court may hold an ex parte hearing on a petition for temporary guardianship, meaning without all of the interested persons present, or hold a hearing within five (5) business days of the petition being filed with the Court providing notice of the hearing pursuant to the Court Rules. The petitioner has the burden of proof by clear and convincing evidence.

In addition to submitting the attachment detailing the reasons for the petition for guardianship, a petitioner seeking temporary guardianship while the permanent guardianship proceedings are pending must submit an additional separate attachment stating in detail the immediate harm the minor will suffer if a temporary guardian is not appointed, the minor's condition(s), if any, and specific examples of the minor's recent conduct that demonstrates the need for the immediate appointment of a temporary guardian.

The petition and attachments must include the written affirmation that the information presented is true to the best of the petitioner's information, knowledge, and belief, be signed and dated by the petitioner, and must be notarized or witnessed by the Tribal Court Clerk, Tribal Court Administrator (TCA), or Assistant TCA.
