ORDER OF PUBLIC NOTICE TO ALL CREDITORS
IN THE ESTATE OF TERRANCE ALBERT CHIVIS (-BAA)
(MAY 19, 1948 TO MAY 4, 2024)

## THE COURT HEREBY FINDS AND ORDERS:

- On May 4, 2024 <u>TERRANCE ALBERT CHIVIS (-BAA)</u>, an Elder and Tribal Citizen of the Little River Band of Ottawa Indians, a federally recognized American Indian Tribe, whose permanent residence was located on the Pine Creek Indian Reservation of the Nottawaseppi Huron Band of the Potawatomi ("NHBP"), a federally recognized American Indian Tribe and who was born on May 19, 1948, walked on.
- 2. As a federally recognized Tribe, the NHBP Constitution is the supreme law of this sovereign Native Nation and establishes in pertinent part: Jurisdiction; Guiding Principles; Citizenship criteria; Sovereign Immunity, and Government structure, powers, and duties with the independent Judicial Branch created in Article XI as the NHBP Tribal Court, a court of general jurisdiction, currently inclusive of the specialized Domestic Violence and Juvenile Courts, and the sole appellate court of last resort entitled the NHBP Supreme Court.
- 3. With <u>TERRANCE ALBERT CHIVIS</u> (-BAA), a Little River Band of Ottawa Indians Tribal Citizen who lived on NHBP land, the NHBP Tribal Court has exclusive jurisdiction.
- 4. Creditors of TERRANCE ALBERT CHIVIS (-BAA), are notified that all claims against the estate will be forever barred unless presented to Personal Representative Mon-ee Zapata and the NHBP Tribal Court at the addresses above within ninety day (90 Days) after the date the Court posted this Order of Public Notice to All Creditors in the Estate of Terrance Albert Chivis (-BAA) (May 19, 1944 to May 4, 2024).
